ORDINANCE 1337

**AN ORDINANCE OF THE CITY OF STANWOOD, WASHINGTON,
REPEALING STANWOOD MUNICIPAL CODE SECTION 9.20.115
AND SECTION 9.08.030, SUBSECTIONS (5), (6), AND (7) RELATING
TO WEAPONS; PROVIDING FOR SEVERABILITY AND EFFECTIVE
DATE**

WHEREAS, The City desires to update the Stanwood Municipal Code to be consistent with Washington State law, particularly RCW 9.41.290.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF STANWOOD,
WASHINGTON, DO ORDAIN AS FOLLOWS:**

Section 1. Stanwood Municipal Code Section 9.08.030, Subsection (5), (6), and (7) are hereby repealed (the remainder of 9.08.030 remains in effect and unchanged).

~~(5) The discontinuance of selling, distributing, dispensing, or giving away of any firearms or ammunition of any character whatsoever;~~

~~(6) The closing of all establishments, portions or departments thereof, the chief activity of which is the sale, distribution, dispensing, or giving away of firearms and/or ammunition;~~

~~(7) Prohibit any person or persons from carrying or possessing upon any street, alley, highway, or public place or vacant premises within the city any firearms, knives, clubs, rocks, bricks, or other weapons, objects or contrivances susceptible for use in causing injury to persons or damage to property;~~

Section 2. Stanwood Municipal Code Section 9.20.115 is hereby repealed.

~~9.20.115 Carrying concealed firearm:~~


~~Unless licensed by lawful authority to carry a concealed weapon, no person shall carry a pistol concealed on his person, except in his place of abode or fixed place of business. (Ord. 390 § 2, 1973).~~

Section 3. Severability. If any section, clause, and/or phrase of this Ordinance is held invalid by a court of competent jurisdiction, such invalidity and/or unconstitutionality shall not affect the validity and/or constitutionality of any other section, clause, and/or phrase of the Ordinance.


Section 4. Effective Date. This Ordinance shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.


