**RESOLUTION 2015-18**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF STANWOOD, WASHINGTON, SETTING A PUBLIC HEARING REGARDING THE CITY'S INTENDED ASSUMPTION OF THE STANWOOD TRANSPORTATION BENEFIT DISTRICT PURSUANT TO THE AUTHORITY OF SECOND ENGROSSED SUBSTITUTE SENATE BILL 5987 (2ESSB 5987).**

**WHEREAS**, Chapter 36.73 RCW provides for the establishment of Transportation Benefit Districts (TBD) and the levying of additional revenue sources for transportation improvements within the district; and

**WHEREAS**, the State adopted 2ESSB 5987 that, effective July 15, 2015, authorizes a city or county that has established a TBD with the same boundaries as the city or county to absorb the TBD and assume all of the TBD's "rights, powers, functions, and obligations," with the result that the TBD would cease to exist as a separate municipal entity; and

**WHEREAS**, the City of Stanwood adopted Ordinance 1328 on or about November 19, 2012 creating Stanwood Municipal Code Chapter 3.40 Entitled "STANWOOD TRANSPORTATION BENEFIT DISTRICT"; forming the Stanwood Transportation Benefit District entirely within the geographical boundaries comprised of the corporate city limits of the City of Stanwood Washington; and

**WHEREAS**, the City Council intends to consider the assumption of the Stanwood Transportation Benefit District coexistent with its boundaries and to exercise all rights, powers, functions and obligations of the Stanwood Transportation Benefit District pursuant to 2ESSB 5987.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STANWOOD, WASHINGTON AS FOLLOWS:**

Section 1. Intent.

Pursuant to 2ESSB 5987 Section 302, it is the intention of the Stanwood City Council to conduct a public hearing concerning the assumption of the Stanwood Transportation Benefit District and to exercise all rights, powers, functions and obligations of the STBD pursuant to 2ESSB 5987.

Section 2. Hearing.

Pursuant to 2ESSB 5987 Section 302, a public hearing is hereby set for October 8, 2015 to consider the of a assumption of the Stanwood Transportation Benefit District coexistent with its boundaries and to exercise all rights, powers, functions and obligations of the Stanwood Transportation Benefit District pursuant to 2ESSB 5987 Sections 301-307.

Said public hearing shall be held in the Council chambers located at the Stanwood-Camano Administrative Building Board Road, 26920 Pioneer Highway, Stanwood, WA 98292 at 7:00 P.M. or as soon thereafter as this matter may be heard.


All persons interested may appear and be heard.

Section 3. Publication.


Pursuant to 2ESSB 5987 Section 302, this Resolution of intention shall be published at least two times during the two weeks preceding the scheduled hearing in the newspaper or newspapers of daily general circulation printed or published in the City in which the Stanwood Transportation Benefit District is located.
